### 3 YEARS [THIRTY SIX MONTHS] NORTH AMERICAN LIMITED WARRANTY For Projectors and Video Processors

**WHAT IS COVERED:** All parts defective in material and workmanship.

**FOR HOW LONG:** 3 years [36 months], Parts & Labor, from the original Wolf Cinema invoice date (excluding the lamp). Lamps are warranted under this Limited Warranty for a period of six (6) months or 1000 hours, whichever comes first, from the original Wolf Cinema invoice date. If replacement parts and/or a lamp are provided under this limited warranty, such parts and/or lamp are warranted for the remaining portion (if any) of the original warranty period.

**WHAT WOLF CINEMA WILL DO:** Wolf Cinema will, at its sole option, repair or replace any defective parts and/or lamp free of charge at either the product's location or at the Wolf Cinema Service Center.

**WHAT WOLF CINEMA WILL NOT DO:** Pay shipping or transportation charges from you to Wolf Cinema. PROVIDE A WARRANTY OR SERVICE FOR PRODUCT NOT PURCHASED FROM AND INSTALLED BY AN AUTHORIZED NORTH AMERICAN WOLF CINEMA DEALER. PLEASE CONTACT WOLF CINEMA IF YOU HAVE ANY QUESTIONS REGARDING A DEALER.

**WHAT YOU MUST DO:** First, contact the dealer from whom you purchased the product to discuss the problem. Your dealer, in most instances, will be able to answer your questions or arrange for repair. In the event you are unable to resolve the situation with your dealer, promptly notify the Wolf Cinema Service Center located at 800 Addison Street, Berkeley, CA 94710 (tel: 510-990-6000) of any defect, malfunction, or nonconformity upon discovery. Obtain from the Wolf Cinema Service Center a return authorization number. Properly pack the product in the **product's original carton** for shipping (ask the Wolf Cinema Service Center for packing instructions, if needed). Label and ship the product, freight prepaid and insured, to the Wolf Cinema

Service Center with the proof of purchase from your authorized Wolf Cinema dealer, and place the return authorization number prominently on the outside of the carton. Cartons not bearing a return authorization number will be refused.

**OTHER CONDITIONS:** This warranty is not transferable from the original owner to any subsequent owners. THE PROVISIONS OF THIS WARRANTY ARE IN LIEU OF ANY OTHER WRITTEN WARRANTY, WHETHER EXPRESS OR IMPLIED, WRITTEN OR ORAL, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. WOLF CINEMA'S MAXIMUM LIABILITY SHALL NOT EXCEED THE ACTUAL PURCHASE PRICE PAID BY YOU FOR THE PRODUCT. IN NO EVENT SHALL WOLF CINEMA BE LIABLE FOR SPECIAL, INCIDENTAL, CONSEQUENTIAL OR INDIRECT DAMAGES. This warranty does not cover a defect that has resulted from improper or unreasonable use or maintenance, accident, improper packing, faulty or improper installation or setup adjustments, or improper input signals, or damage due to lightning or power line surges, spikes, or brownouts, or unauthorized tampering, alteration or modification as determined solely by us. This warranty does not cover damage that occurs during shipping or transit, or damages attributed to acts of God. This warranty does not cover normal maintenance. This warranty is void if the label bearing the serial number has been removed or defaced. Also excluded from this limited warranty coverage are any remote control units where damage results from leaking, old, damaged or improper batteries.

**This warranty only applies to product that is purchased, installed, setup, and calibrated by an authorized Wolf Cinema dealer.**

**OTHER LEGAL RIGHTS:** This warranty gives you specific legal rights, and you may also have other rights, which vary from country to country or state to state. Some places do not allow limitations on implied warranties or the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.

**REGISTRATION:** Product registration is not required. Your original sales receipt from a Wolf Cinema authorized retailer serves as the document required for any and all warranty service claims. The invoice from Wolf Cinema to its authorized dealer documents the date of purchase which determines the commencement date of this limited warranty period.

**EFFECTIVE DATE:** This Warranty is in effect for all units purchase on or after June 1, 2014. All units previously purchased from the Company prior to that date remain subject to the terms and conditions as stated in our previous 27 Month Warranty Program.
